




TYPICAL FRONT-LOAD DIN MOUNTING METHOD

9. USB port


Main Menu

Press Sound Effect icon in the Settings menu to select EQ Presets, Surround Settings, Fader and Balance controls.



USB / microSD Card Operations

microSD operation will work the same way when you insert the microSD card into unit's microSD card slot.



Bluetooth Operation

Bluetooth Microphone

The microphone is built-in to the receiver.

Pairing and Connecting

Before using Bluetooth functions, you must pair your mobile phone to the receiver. The device name is "JENSEN CMR2720". To ensure the best reception for pairing and re-connection, please make sure the mobile phone battery is fully charged before you begin.

- Try to perform pairing within a few minutes of the mobile phone being turned on.
- Once the unit has been paired with the mobile phone, the unit's model number, "CMR2720", will be displayed on the mobile phone.
- To achieve the best performance, always keep the mobile phone within 10 feet (3 meters) of the unit.
- Always keep a clear path between the mobile phone and the unit. Never place a metal object or any other obstacle between the mobile phone and the unit.
- Some mobile phones may have a "Power Saving Mode" option. PLEASE DO NOT use the power saving mode with the CMR2720.
- Before accepting or making a call, make sure your mobile phone's "Bluetooth function" is turned on.
- To ensure the best conversation quality/performance, stay within 3 feet (1 meter) of the unit's microphone when talking.

Dialing a Number

Press to display keypad and dial a number.



Making and Ending a Call


Press to connect a call, and press to end a call.

Transferring Audio

Press to transfer audio between the head unit and mobile phone.

Streaming Audio

Press to play or pause the music.
Press to skip to the previous track.
Press to advance to the next track.



Voice Activation Operation

Bluetooth should be paired between your smartphone and the receiver. Press the voice activation button , and the receiver will switch into Bluetooth mode. This will activate Siri® or Google Assistant™ on your smartphone. You will need to manually switch back to the previous or desired mode once this operation is terminated.

Navigation App Operation (audio only)

Activation of Jensen Smart App should not be closed, but open on your smartphone for this operation. Touching will guide you instant access to your favorite navigation App on your smartphone. Please refer to the complete manual on <https://www.jensenmobile.com/user-manuals.html>
